Re: Extension and Amendment No. 1 to NIKE All-Sport Agreement

Dear Eddie:

I am pleased we were able to reach agreement on an extension to the University of New Mexico's All Sport Agreement with NIKE USA, Inc., which was effective August 1, 2020 (the "Agreement"). This letter (this "Amendment No. 1") will serve as our agreement to the extension and amendment of the Agreement. Specifically, effective July 1, 2023, we agree that the Agreement will be amended as follows:

Section 2 Extended Term	Section 2 is deleted in its entirety and replaced with the following: The Term is extended for a period of four Contract Years, to commence July 1, 2023 and end June 30, 2027, unless sooner terminated in accordance with the Agreement.
Section 5(c) NIKE Elite Allotment	Section 5(c) is deleted in its entirety and replaced with the following: Each Contract Year, in addition to the Annual Product Allotment, UNIVERSITY shall be entitled to order up to \$150,000 (retail value) through "NIKE Elite" Client Services (and subject to procedures established by NIKE for such purposes), for use of UNIVERSITY Coaches and Staff (with such allocation among Coaches and Staff to be determined at the discretion of the Director of Athletics). No carry-over of unordered annual allotments through NIKE Elite from one Contract Year to another shall be allowed.
Section 13(a) Update to Exclusive Negotiating End Date Definition	In Section 13(a), only the definition of "Exclusive Negotiating End Date" shall be updated and redefined as follows: The Exclusive Negotiating End Date is defined to be 12 months prior to the expiration of the Term. For example, if the Term expires on June 30, 2027, the Exclusive Negotiating End Date shall be June 30, 2026.

All capitalized terms not defined in this Amendment No. 1 shall have the meaning given to such terms in the Agreement. Except as modified by this Amendment No. 1, all other terms of the Agreement shall remain in full force and effect and all rights and obligations under this Amendment No. 1 shall be exercised consistent with the Agreement.

We are pleased to have reached this extension and look forward to the continuation of our relationship.
