Official Athletic Contest Contract

This Agreement is entered into between the parties, TEXAS TECH UNIVERSITY and University of New Mexico. The parties agree to the following terms and conditions, effective this 18 day of November, 2019:

- 1. TEAM PLAY:** The Baseball teams of the two above mentioned institutions will play 2 contest(s) of Baseball on the following dates, sites and times below, as guaranteed for the following sums:
on March 17, 2020, at UNM at TBD A.M./P.M. Guarantee \$ -0-
on March 18, 2020, at UNM at TBD A.M./P.M. Guarantee \$ -0-
on April 13, 2020, at Rip Griffin Park at TBD A.M./P.M. Guarantee \$ -0-
on April 14, 2020, at Rip Griffin Park at TBD A.M./P.M. Guarantee \$ -0-
- 2. ELIGIBILITY:** The contest(s) are governed in all respects, including eligibility of the team participants, by the respective conference, institution, and/or association rules.
- 3. FINANCIAL ARRANGEMENT:** In consideration of playing the above listed contest(s), the home team agrees to pay to the visiting team the sum(s) listed above, as a guarantee per contest, to be paid on or before thirty (30) days after the contest.
- 4. BREACH OF CONTRACT:** In case either party fails to produce its team and play said contest on said date at the place agreed, or breaks any clause of this contract without the permission of the other party to this agreement, it shall pay to the party not at fault the sum of \$ 5,000.00, as forfeit within one week of the date on which the contest was to occur.
- 5. COMPLIMENTARY TICKETS:** The visiting team will be given complimentary tickets or a pass list for -20- people.
- 6. GAME OFFICIALS:** Game officials will be appointed by Division I certified, and the expenses of said officials are the responsibility of the home team.
- 7. EXIGENT CIRCUMSTANCES:** This Agreement will be canceled and both parties will be released from any liability or damages if the parties are unable to fulfill the terms of this Agreement due to an act of God or any legitimate conditions beyond the control of the home team, provided the visiting team is notified of said conditions prior to arrival at the site of the contest. The home team agrees to exercise its best efforts to insure that the contest(s) occur as scheduled.
- 8. CANCELLATION CLAUSE:** This Agreement may be modified or canceled at any time by mutual consent of the parties, or due to any circumstances beyond the control of either party.
- 9. MISCELLANEOUS PROVISIONS:** Texas Tech and New Mexico will cover 15 rooms for two nights for a total of 30 rooms per trip.
- 10. DISPUTE RESOLUTION:** The parties will utilize the dispute resolution process provided for in Texas Government Code 2260 for all disputes arising from this Agreement.
- 11. Trafficking of Persons:** Under §2155.0061, Texas Government Code, the Contractor certifies that the individual or business entity named in the bid or Contract is not ineligible to receive the specified Contract and acknowledges that the Contract may be terminated and payment withheld if this certification is inaccurate.

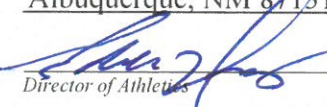
