**INTERCOLLEGIATE ATHLETICS CONTRACT**

The University of New Mexico ("UNM") and Ball State University  
(Party of the First Part / Home Team) (Party of the Second Part / Visiting Team)

THIS AGREEMENT, made and entered into this 19th day of October, 2018  
BY and BETWEEN the Party of the First Part and the Party of the Second Part, by their duly-authorized agents, stipulates as follows:

**FIRST:** That the Women's Basketball teams representing the above-named institutions agree to meet in Albuquerque, New Mexico on Wednesday, December 18<sup>th</sup> and on Thursday, December 19<sup>th</sup> and on Friday, December 20<sup>th</sup>, 2019. For The Lobo Invitational at Dreamstyle Arena A.K.A. the PIT. Time: TBA.

\*Contact must be signed and returned to UNM within 14 days via email\*.

**SECOND: (GUARANTEE)** that in consideration for playing in the above-named contest(s), the management of the home team shall pay to the management of the visiting team the sum of \$10,000.00.

**(ENTRY FEE)** That in consideration for playing the above-named contest(s), the management of the visiting team shall pay to the management of the home team the sum of (\$ N/A) Dollars.

**THIRD:** That officials for such contest(s) shall be assigned by the Mountain West Conference.

**FOURTH:** That the eligibility rules governing participation in such contest(s) shall be those established by the faculties of the respective institutions and the Athletic Conferences involved.

**FIFTH:** That 50 complimentary tickets shall be provided to the visiting team for the above contest(s).

**SIXTH:** The University of New Mexico retains all radio and television rights.

**SEVENTH:** That if either institution refuses to play at the time and place agreed upon, except for some other breach of contract by the other, the management of the team of the institution refusing to play shall forfeit to the management of the other team the sum of (\$10,000.00 ) ten thousand Dollars.

**EIGHTH:** That the following additional provisions shall apply: Hotel accommodations: N/A

\*Tournament Exempt: You may add a 4<sup>th</sup> game to be played at your facility at your expense vs a Non-D1 within 14 days prior to December 18<sup>th</sup>, 2019.
