ATHLETICS EVENT CONTRACT

This agreement is made and entered into this 7th day of May 2025, by and between The University of Texas at Arlington ("UTA") and The University of New Mexico ("Visiting institution"). UTA and Visiting Institution may be referred to individually as a "party" and collectively as the "parties".

The parties agree to the following stipulations:

FIRST: The women's basketball teams representing the parties shall participate in an exhibition contest:

VENUE: College Park Center

DATE: October 28, 2025

TIME: 5:00 PM

SECOND: UTA will provide the guarantees and financial arrangement as follows:

- Return trip to New Mexico for an exhibition game during the 2026-27 season

Failure to fulfill the conditions of this contract will be cause for a penalty in the amount of \$25,000, to be paid by the breaching party to the innocent party within two weeks of the date of the contest, unless mutually agreed upon in writing by both parties and unless such cancellation/forfeiture is due to an act of Force Majeure, or other event/condition beyond the control of the innocent party.

THIRD: This contest shall be governed in all respects, including the eligibility of participants therein, by the rules and regulations of the NCAA (National Collegiate Athletic Association) or any conference or association to which either or both of the parties may belong.

FOURTH: Officials shall be assigned by the Supervisor of Women's Basketball Officials for the Western Athletic Conference or its successor.

FIFTH: Visiting team shall be allowed 50 complimentary tickets.

SIXTH: Other provisions or arrangements shall include: n/a

SEVENTH: The parties agree to allow the use of their names and respective logos or other identifying marks, solely for the purpose of promoting the contest.

By signing this Contract, I acknowledge and affirm that I understand and agree to abide by the terms and conditions of this Contract. I am an authorized representative of my party and have full authority to bind my party to the terms and conditions of this Agreement.
