INTERCOLLEGIATE ATHLETICS CONTRACT

THE UNIVERSITY OF NEW MEXICO ("UNM") AND SAM HOUSTON STATE UNIVERSITY
(PARTY OF THE FIRST PART / HOME TEAM) (PARTY OF THE SECOND PART / VISITING TEAM)

THIS AGREEMENT, MADE AND ENTERED INTO THIS 25TH DAY OF FEBRUARY, 2016
BY AND BETWEEN THE PARTY OF THE FIRST PART AND THE PARTY OF THE SECOND PART, BY THEIR
DULY-AUTHORIZED AGENTS, STIPULATES AS FOLLOWS:

FIRST: THAT THE TEAMS REPRESENTING THE ABOVE-NAMED INSTITUTIONS AGREE TO MEET IN A FOOTBALL
GAME AT ALBUQUERQUE, NEW MEXICO ON **AUGUST 31ST, 2019** AT (TIME TBA).

SECOND:
(GUARANTEE) THAT IN CONSIDERATION FOR PLAYING IN THE ABOVE-NAMED CONTEST(S), THE
MANAGEMENT OF THE HOME TEAM SHALL PAY TO THE MANAGEMENT OF THE VISITING TEAM THE SUM OF
(\$350,000) DOLLARS. THE HOME TEAM WILL ALSO PROVIDE 50 ROOMS AT A LOCAL FULL-SERVICE HOTEL
AGREED UPON BY THE VISITING TEAM ON FRIDAY, AUGUST 30TH

(ENTRY FEE) THAT IN CONSIDERATION FOR PLAYING THE ABOVE-NAMED CONTEST(S), THE MANAGEMENT OF
THE VISITING TEAM SHALL PAY TO THE MANAGEMENT OF THE HOME TEAM THE SUM OF (\$0) DOLLARS.

THIRD: THAT OFFICIALS FOR SUCH CONTEST(S) SHALL BE ASSIGNED BY THE MOUNTAIN WEST
CONFERENCE.

FOURTH: THAT THE ELIGIBILITY RULES GOVERNING PARTICIPATION IN SUCH CONTEST(S) SHALL BE THOSE
ESTABLISHED BY THE FACULTIES OF THE RESPECTIVE INSTITUTIONS AND THE ATHLETIC CONFERENCES
INVOLVED.

FIFTH: THAT 400 COMPLIMENTARY TICKETS SHALL BE PROVIDED TO THE VISITING TEAM FOR THE ABOVE
CONTEST(S).


SIXTH: THAT THE UNIVERSITY OF NEW MEXICO RETAINS ALL RADIO AND TELEVISION RIGHTS.

SEVENTH: THAT IF EITHER INSTITUTION REFUSES TO PLAY AT THE TIME AND PLACE AGREED UPON,
EXCEPT FOR SOME OTHER BREACH OF CONTRACT BY THE OTHER, THE MANAGEMENT OF THE TEAM OF THE
INSTITUTION REFUSING TO PLAY SHALL FORFEIT TO THE MANAGEMENT OF THE OTHER TEAM THE SUM OF
(\$350,000) DOLLARS.

EIGHTH: THAT SAM HOUSTON STATE UNIVERSITY WILL MEET THE SCHOLARSHIP REQUIREMENTS OF NCAA
BYLAW 18.7.2.1.1 FOR CONSIDERATION OF QUALITY BOWL OPPONENTS. IF FOR WHATEVER REASON SAM
HOUSTON STATE UNIVERSITY DOES NOT MEET THIS REQUIREMENT, "UNM" MAY OPT OUT OF THE GAME.
