1. In consideration for playing in the above-named contest(s), the management of the home team shall pay to the management of the visiting team the sum of (\$0.00) Dollars. In consideration for playing the above-named contest(s), the management of the visiting team shall pay to the management of the home team the sum of (\$0.00) Dollars.
2. Officials for such contest(s) shall be assigned by the Mountain West Conference.
3. The eligibility rules governing participation in such contest(s) shall be those established by the faculties of the respective institutions and the Athletic Conferences involved.
4. Visiting team shall be allowed 30 complimentary tickets for the above contest(s).
5. The University of New Mexico retains all television rights.
6. The Parties agree that if either institution breaches this contract by refusing to play at the time and place agreed upon, the non-breaching party shall sustain damages that are difficult (if not impossible) to calculate. Therefore, the Parties agree that in the event of one party refusing to play at the time and place agreed upon, it shall pay to the other party, as liquidated damages and not as a penalty, the sum of (\$10,000.00) Dollars.
