Competition Agreement



This Competition Agreement ("Agreement") is made and entered into on March 27, 2023, by and between the UNIVERSITY OF SAN DIEGO ("USD" or "Host Institution") and the UNIVERSITY OF NEW MEXICO ("UNM" or "Visiting Institution").

The parties agree to the following stipulations:

1. To participate in the following **Women's Soccer** competitions:
 - **Thursday, August 31, 2023, at 7:00 p.m., at the University of San Diego.**
 - **Sunday, September 1, 2024, at 1.00 p.m., at the University of New Mexico** MM
Mm
2. That guarantees and financial arrangements will be as follows: **None.**
3. Each party shall adhere at minimum to all COVID-19 testing protocols as set forth by the NCAA and the West Coast Conference as of the competition date. Each party shall be responsible for its own arrangements and expenses related to testing.
4. That the above contests shall be governed in all respects, including the eligibility of participants therein, by the rules and regulations of the National Collegiate Athletic Association, and any conference or association to which either or both of the parties may belong.
5. Officials shall be the responsibility of the Host Institution.
6. The Visiting Institution shall be allowed **40** complimentary tickets.
7. Other arrangements shall include: Visiting team may produce a Radio broadcast, but no Television broadcast shall be done without the express permission of the Home Institution. All broadcasts and cablecasts of games are subject to rights and fees as designated by the Home Institution.
8. In case of cancellation, or failure to appear for the contest, the party canceling or failing to appear shall pay a Cancellation Fee to the other party in the amount of **\$3,000** as a direct result of the cancellation/forfeiture, unless it is due to an act of God, pandemic or other event or condition beyond the control of the institution.
9. The persons executing this Agreement on behalf of their respective parties warrant that they are duly authorized to contractually bind their institution.
