EVENT CONTRACT

The Agreement entered into this day of 05/05/2021 by and between
CALIFORNIA STATE UNIVERSITY, FULLERTON (CSUF) and
UNIVERSITY OF NEW MEXICO shall be as follows:

That the **Women's Volleyball** team representing **University of New Mexico** shall compete
in games for the:

Titan Classic

Friday, August 27th & Saturday, August 28th, 2021 at CSUF Titan Gym
@ Times (PST) per attached schedule

- I. **Financial Arrangements:** Proceeds delivered from programs, concessions, radio and television broadcasts and any other source shall belong to the home institution exclusively. Also, that in consideration of such event(s) the financial arrangements shall be as follows: CSUF will pay a guarantee of two-thousand five hundred dollars (\$2,500.00) to the visiting team's management. Payment will be issued prior to the competition.
- II. **Rules:** Said contests shall be governed by applicable NCAA legislation and playing rules, and by the rules of host institution's conference. The athletics eligibility of each team's student-athletes shall be governed by the rules and regulations of the represented institutions, of the institution's athletic conference and by the NCAA.
- III. **Officials:** The officials shall be provided by the Big West Conference.
- IV. **Tickets:** The visiting management shall be provided zero (0) complimentary tickets.
- V. **Cancellation Clause:** This agreement may be modified or canceled at any time by mutual consent of the parties hereto. If a party fails to produce its team and play said contest on the agreed upon date and place, or breaks any clause of this contract without the permission of the other party, it shall pay the non-defaulting party the sum of ten thousand dollars (\$10,000) as forfeit within one week of the scheduled contest date. If an act of God or any conditions beyond the reasonable control of one party renders that party unable to produce its team and play said contest on the agreed upon date and place, that party shall be released from liability or damages hereunder. Both teams agree to exercise their best efforts to ensure that the contest will be conducted as scheduled. In the event that either party considers it necessary or prudent to cancel this agreement due to circumstances related to the COVID-19 outbreak, that party may do so and be relieved of any further financial obligation, risk, or other liability by providing Twenty-Four (24) hours prior written notice of cancellation to the other party.
- VI. **Comments:** COVID-19 protocols will be communicated at a later date and will be dependent upon consideration of city, county, state, NCAA and conference requirements at the time of competition.
