| <b>FORCE MAJEURE:</b>         | "For the absence of doubt, if there is still a pandemic requiring regular testing for participation in athletic events, it will be deemed to be force majeure if either party does not pass the applicable testing requirements and cannot field a team for the contest, or if local health guidelines no longer permit the playing of the contest." "If still in effect at the time of the competitions, both institutions agree that before participating in the competition, it will comply with the applicable COVID 19 Testing Protocol (as it may be amended from time to time) in effect at that time. Each institution will pay for their own testing expenses."                                                                                                               |
| <b>VIDEO RIGHTS:</b>          | The host institution shall have all rights of telecast, including but not limited to, national network television, national cable, Conference Networks, Internet streaming, delayed telecasting, unlimited highlights, institutionally syndicated packages and telecasting by any and all other means. The Visiting Institution agrees to the following: (1) The scheduled start time for the game(s) is solely at the discretion of the Host Institution and may be changed up to six (6) days in advance of the game in order to accommodate television. (2) Any change in the date of the game(s), including changes for television, must be mutually agreed upon by the participating institutions. (3) Media timeout formats are determined by the Host Institution's conference. |
