University of New Mexico

1. Sport: Women's Volleyball

2. Date: August 25, 2023 vs Seton Hall **Place:** UC Irvine **Time:** 10:00am

Date: August 25, 2023 vs UCI **Place:** UC Irvine **Time:** 7:00pm

Date: August 26, 2023 vs San Francisco **Place:** UC Irvine **Time:** 1:00pm

3. Officials: Responsibility of host institution to arrange for contest officials.

4. Guarantee: UCI to provide visiting team with 24 hotel room nights (total). Property TBA.

5. Complimentary Tickets: 40 to be provided to visiting institution.

6. Unforeseen Circumstances: If either party is delayed or interrupted in or prevented from the performance of its obligations hereunder by reason of an acts of God, fires, flood, war, public disaster, pandemic, strikes or labor difficulties, governmental enactment, regulation or order, or any other cause beyond its control, such party shall not be liable to the other therefore.

7. Cancellation: Except as provided in paragraph 6, if either party unilaterally cancels or otherwise breaches the terms of this agreement (hereinafter "canceling party"), that party shall reimburse the other a termination fee in the amount of : \$ 10,000.00.

8. Media: The visiting team shall have access to one radio broadcast outlet. All other broadcast rights, privileges, receipts there from shall belong to host institution in accordance with its media rights agreements.

9. Governance: This contest shall be governed in all respects, including the eligibility of participants therein, by the rules and regulations of the National Collegiate Athletic Association, any conference or association to which either or both of the parties may belong, and the rules and regulations of the parties hereto. This agreement shall be governed by the laws of the State of California.

10. Other Conditions: NCAA Resocialization, State and Local health guidelines to be followed by both institutions. UC Irvine to return to Univ. of New Mexico in 2024 season.

11. Date of Agreement: March 23, 2023

12. Authorization: The persons executing this agreement on behalf of the respective parties hereto hereby warrant that they are duly authorized and empowered by the parties hereto so to execute.
